#### EAST WINDSOR TOWNSHIP COUNCIL

Tuesday, August 3, 2010

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 8:00 p.m. on August 3, 2010.

Municipal Clerk Cindy A. Dye certified that the meeting was noticed in the Annual Meeting Notice. Notice was sent to the Trenton Times, filed with the Municipal Clerk and posted in the East Windsor Township Municipal Building, all on January 5, 2010. All requirements of the "Open Public Meetings Act" were satisfied.

Council Member Marsha Weinstein led the flag salute.

Mayor Mironov stated that the Tax Assessor and Tax Collector are available this evening to meet with any residents. The Township does not set the assessments. The assessments are done through the direction of the State to the County Tax Board. The State of New Jersey sets up the system in determining property values. The firms used to do the revaluation have to be a State qualified firm. The County Tax Board is appointed by the Governor and the Tax Assessors are

accountable to the State County Tax Board for the performance of their function. Mayor Mironov indicated that the Township will follow-up regarding any person who did not receive the letter of assessment and if there are any recourse.

Mayor Mironov explained that the Township is still trying to get back the Energy Tax Receipts that the State decided to take. She explained how the Energy Tax Receipts supported the budget.
