#### EAST WINDSOR TOWNSHIP COUNCIL

Tuesday, December 7, 2010

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 8:00 p.m. on December 7, 2010.

Municipal Clerk Cindy A. Dye certified that the meeting was noticed in the Annual Meeting Notice. Notice was sent to the Trenton Times, filed with the Municipal Clerk and posted in the East Windsor Township Municipal Building, all on January 5, 2010. All requirements of the "Open Public Meetings Act" were satisfied.

Deputy Mayor Lippman led the flag salute.

#### **REPORTS BY COUNCIL AND STAFF:**

Mr. Shapiro stated the Planning Board had met the previous night. He stated that the applicant for Regency Woods development had come to the Board asking to change their main entrance from Probasco Road to Wyckoff Mills Road. The Board voted to approve a project from the Peddie School to build a solar array next to the new athletic center.

Mr. Daniels stated that the Drug Alliance had met the previous week.

Mayor Mironov stated the Economic Development Committee met December 2. They discussed a welcome package for new businesses, a card exchange, and a solar energy seminar for the community. They also discussed the printing of a new East Windsor map.

#### **APPOINTMENTS:** None

#### **APPROVAL OF BILLS:**

Listed for approval were a current 2010 bill list, a current 2009 bill list, and a capital bill list, all dated December 1, 2010, as well as other miscellaneous and trust account bill lists.

Mayor Mironov stated she had asked about the items relating to Disbrow Hill Road/Etra Road on page 2 of the bill list.

Mr. Fisher stated there were for advertising for bids.

Mayor Mironov asked if there was a legal requirement that the Township advertise for bids in the newspaper. She asked about the vision reimbursements items on page 4. She requested that those bills be held.

It was MOVED by DUKE and seconded by SHAPIRO be approved with the changes.

#### **MATTERS BY COUNCIL:**

Mayor Mironov stated there was a Tax Collector's report for the period ending November 17. A report dated November 30 was received by the Public Works engineering aide regarding a partial road closure of Etra Road and Ward Street; she noted this was in conjunction with the new Public Works facility.

Mayor Mironov stated she distributed a letter from Womanspace asking the Township to participate in a tree-lighting facility in April. She stated communication was received on the Department of Community Affairs best practices checklist and noted the Township would be receiving all its money. She asked Mr. Fisher if the Independence Day celebration had been confirmed for the date decided by Council.

Mr. Fisher stated he was not aware of any issues.

Mayor Mironov asked Mr. Fisher to advise when the Recreation Department intended to present summer program ideas. She stated that a release was issued indicating effective January 1, 2011 a new state law would go into affect requiring the recycling of computer equipment and television. She noted the Womanspace's Community of Light would take place December 13.

## **MATTERS BY PUBLIC: None**

#### DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Stream Clean-Up with Stony Brook Millstone Watershed Association

Mayor Mironov stated a letter was received from the Watershed Association dated November 16 asking if the Township wished to participate in the spring clean-up event. She noted they had requested a response by January 7. She asked when the next Environmental Committee meeting was.

Ms. Weinstein stated the next meeting was December 15.

Mayor Mironov stated the coordinator of the event had offered to meet with the Committee. She asked Ms. Weinstein to come back with a report. She noted the only concern when setting a date was to avoid it landing on the same date as the Recycling Day.

Council agreed it was favorable to participate in the program.

2. Township Insurance for 2011/Status

Mayor Mironov asked Mr. Fisher what the status of the project was and when he intended to have materials to present to the governing body.

Mr. Fisher stated that the insurance agent solicited quotes from 5 companies, as well as the current carrier. He stated a recommendation would be forthcoming to the governing body.

Mr. Lippman asked if it would include materials from all of the quotes.

Mr. Fisher stated yes.

Mayor Mironov asked for information on how much and in what way the insurance broker is paid, and clarification on their relationship with the fund to which the Township belongs.

3. Health Benefits: Administration of Supplement Insurance/Status

Mayor Mironov stated she needed a status update on how other communities handle the administration of the supplemental insurance and on how the Township was handling or intended to handle the issue.

Mr. Fisher stated he had contact with some municipalities, and intended to follow up in the future as to present a report in February.

Mayor Mironov asked when the current contract ended.

Mr. Fisher stated June 1, 2011.

4. 2011 Municipal Budget Draft

Mayor Mironov stated it was listed as it was necessary the governing body had numbers as soon as possible to plan for the coming year. She asked Mr. Fisher when she could expect materials.

Mr. Fisher stated he expected to have the material to the Mayor that Friday.

Mayor Mironov stated in the previous year, a subcommittee was appointed for the budget, and that she would likely do this again.

5. Cell Tower Facility at Police Building

Mayor Mironov noted this had been previously discussed, and they had been in discussions to add to the facility. She noted Council had an update from her office regarding this. She stated if it was the desire of the Council to move forward, and noted this would be her recommendation.

Council agreed to move forward with the project.

Mayor Mironov asked Mr. Orron if a resolution was needed to start the process.

Mr. Orron stated a resolution was needed to authorize bidding and set the bid specifications.

Mayor Mironov asked if the bidding process was necessary if it was solely a land issue.

Mr. Orron stated that did not apply to this case.

Mayor Mironov stated this would be listed on the December 21 agenda.

There being no further business Mayor Mironov adjourned the meeting at 9:15 p.m.
