#### EAST WINDSOR TOWNSHIP COUNCIL

Tuesday, August 2, 2011

The meeting of the East Windsor Township Council was called to order by Mayor Janice S. Mironov at 8:00 p.m. on August 2, 2011.

Municipal Clerk Cindy A. Dye certified that the meeting was noticed in the Annual Meeting Notice. Notice was sent to the Trenton Times, filed with the Municipal Clerk and posted in the East Windsor Township Municipal Building, all on January 7, 2011. All requirements of the "Open Public Meetings Act" were satisfied.

Council Member Alan Rosenberg led the flag salute.

### **MATTERS BY COUNCIL:**

Mayor Mironov stated that there is a letter dated July 21 indicating that the records committee found the imaging processing system for public records is in compliance. The Emergency Operations Plan has been approved. There is a Mayor Advisory letter circulated regarding the State residency requirement for public employees. The Township is accepting nominations for the Business Awards Program. The Disbrow Hill Road Playing Fields fence is erected.

Mayor Mironov requested a report from staff regarding the Best Practices checklist. This matter is to be placed on the next agenda.

Mayor Mironov stated that there was to be a student intern to work on the Sustainable Jersey material.

Mr. Fisher responded that he has been working on it.

### DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Bicycle Helmet Safety Program

Mayor Mironov stated that previously the Township had conducted a very pro-active multi-phase bicycle program. There are grant applications pending and are very hopeful in receiving a positive response. In the meantime, other grant funds have been identified that could be used

towards a program in the fall. This program would be for one night. The bicycle helmet programs consist of informational material, a five minute video and a helmet that is properly fitted. Statistics show that not only wearing the helmet is critical; however, it must be properly sized and adjusted to work effectively.

The Council unanimously agreed to move forward with the program. Mayor Mironov will work with Chief Spain to work out the particulars on the date and time.

# 2. Updated East Windsor Street and Road Map

Mayor Mironov stated that this was previously discussed and it was agreed that the Township use the company who did the map previously. Staff is working, in conjunction with the Economic Development Committee, to update the text on the map.

Regarding the information portion of the text, Mayor Mironov asked if there any subject area that anyone may feel that needs to be included. There have been a couple of items removed because they are not very useful or become untimely quickly.

Mr. Lippman asked if the bicycle pathways could be marked out on the map.

Mayor Mironov requested the opinion of the Council regarding the cover of the map and pictures displayed inside the map.

It was consensus of Council that the Lee Turkey Farm and Etra Lake pictures should be the cover of the map; inside the map, there should be photos of prominent businesses situated around the East Windsor sign; the e-news and newsletter should be advertised in a separate box with the Township's website; additional stores should be mentioned when listing shopping centers, i.e., TJ Max for East Windsor Village Shopping Center and the Mayor's letter should be position in the front of the map as it opens so it is the first thing residents see.

## 3. 9/11 Observance

A. East Windsor Township Ceremony and Memorial

Mayor Mironov stated that 9/11 falls on a Sunday this year. The Township has scheduled a local observance in East Windsor on that Sunday at 2 p.m. on the municipal building grounds in the area of the 9/11 memorial.

Mr. Shapiro explained the physical improvements that will be made to the memorial.

Mayor Mironov explained that the Township will have an extensive program on September 11 at 2 p.m. There will be participation by many groups throughout our community. She asked if any Council member has any ideas that they can bring it to her attention.

Mayor Mironov indicated that East Windsor lost the most number of residents than any other town in Mercer County due to the 9/11 events. The families have been invited to the Township's observance.

### **B. Resolution R2011-170**

A Resolution Expressing the Sense of the East Windsor Township Council Regarding Coming Together as a Nation and Ceasing All Work or Other Activity for a Moment of Remembrance Beginning at 1:00 PM Eastern Daylight Time on September 11, 2011, in Honor of the 10th Anniversary of the Terrorist Attacks Committed Against the United States on September 11, 2001

The Municipal Clerk read by title Resolution R2011-170.

Mayor Mironov stated that she received a phone call from Senator Lautenberg's office regarding this resolution. He sponsored Senate Resolution 237 and asked if the Mayor and Council would adopt the resolution.

Mayor Mironov recommended adding a paragraph on this resolution as number 7 "Call upon the members of our community to join together at the municipal building grounds at 2:00 p.m. to join in a community-wide remembrance and observance of the 10th Anniversary of September 11."

Mr. Shapiro requested that in the title "in honor" be changed to "in remembrance".

It was MOVED by SHAPIRO and seconded by DUKE that Resolution R2011-170 be adopted with the changes.
