APPROVAL OF BILLS:

Listed for approval were Current 2011 bill list dated June 23, 2011, Current 2010 bill list dated June 23, 2011 and a Capital bill list dated June 23, 2011, as well as other miscellaneous and trust account bill lists.

Mr. Shapiro questioned the Fire Company No. 2 bill – State Fire Grant, on the current 2011 bill list, page 9.

Mr. Fisher explained how the money is distributed for this grant.

Mr. Shapiro questioned page 10 of the current 2011 bill list, the bill forward Hightstown Borough for water service.

Mr. Fisher explained that this bill is from the construction of the New Jersey Turnpike and the agreements made with the New Jersey Turnpike Authority.

Mr. Shapiro questioned current 2011 bill list, page 17, motor fuel.

Mayor Mironov explained that this is budgeted money for the shared fueling facility.

Mayor Mironov asked if the Banc3 bill under the capital bill list is for the Twin Rivers project. Mr. Fisher confirmed it was. Mayor Mironov again requested that the project name be listed on the bill list.

It was MOVED by YEAGER and seconded by ROSENBERG that the bills be approved.

MATTERS BY COUNCIL:

Mayor Mironov stated that Council received a letter from the New Jersey Department of Transportation dated June 20 regarding the Township's request for Route 33 and Hickory Corner Road. This matter will be scheduled for discussion at the July 12 meeting. A letter was also received regarding the red light running cameras, which will also be scheduled for the July 12 meeting. A letter was received from Wheaton Pointe regarding the town hall meeting. A Tax Collector's report was received for the month ending May 31, 2011. A memo was received from the principal engineering aid regarding a partial road closure for Richardson Lane. A memo was received from the principal engineering aid regarding a partial road closure for Conover Road. Mayor Mironov indicated that she circulated the tax bill insertion to Council Members for their comments.

Mayor Mironov requested staff to review feasibility of DCA Small Cities Grant for housing rehabilitation and public facilities and provide a report to her. She also requested staff to review East Windsor COAH program and Housing Trust Fund and the revolving loan fund under the housing rehabilitation program and report to her. She also requested staff to review the DVRPC Transportation Community Development Initiative Grant to see if feasible and report her.

Mayor Mironov stated that the Independence Day Celebration is scheduled for this weekend. There is also a calendar for summer events.

Mayor Mironov stated that she received a Mayor's letter from the New Jersey State League of Municipalities indicating that the Governor conditionally vetoed Senate Bill S-2006 regarding solar panels. She received a Dear Mayor letter regarding the State master plan.

1. Action on Bids for Plenary Retail Distribution License

Mayor Mironov stated that the Council earlier put out a retail license for bid. The bid amount is \$475,000.

2. Renewable Energy Municipal Policy/Regulations

Resolution R2011-145 Resolution Adopting a Policy on Renewable Energy and Farmland Retention

The Township Clerk read by title Resolution R2011-145.

Mayor Mironov stated that this matter has been discussed in the pass. The staff was directed to put a writing together to provide a general statement on the position of the municipal government. Basically what this resolution does, it reaffirms and memorializes in a policy statement the goals, intents and purposes of East Windsor Township and Township Master Plan, and a series of related documents that have guided the town as well, including our Recreation and Open Space Plan. It also reaffirms the governing body's actions over the many years to proactively preserve and support farmland and open space in our community. This Resolution sets forth a re-affirmation of those goals in the light of the extensive activity that renewable energy has been receiving in this past year.

Regarding the Governor's Energy Master Plan document, the one area Mayor Mironov wished to comment on and she thought was very positive was re-balancing the renewable energy goals of the State and the very critical and important goal of supporting, promoting and preserving our farming industry and our farmland and open space.

It was MOVED by SHAPIRO and seconded by ROSENBERG that Resolution R2011-145 be adopted.

Mayor Mironov stated that this resolution will be distributed to our planning board, zoning board of adjustment, environmental commission, New Jersey State League of Municipalities and to the Governor's office.

There being five (5) ayes and no nays, Resolution R2011-145 was adopted.

3. Alternate Energy Suppliers

Mayor Mironov stated staff is to be looking into all of the Township's energy suppliers. Mayor Mironov asked if there could be more of a direct timeline

Mr. Rosenberg indicated that this is something that should be looked into and could save the Township a great deal of money.

Mr. Yeager stated that he feels that this could save the Township money and it would be irresponsible not to look into this.

Mayor Mironov stated that if for some reason this is not a feasible subject, it should be reported to Council. If it is feasible, an action plan and reasonable timeline should be prepared so that this process can get moving.
