Mayor Mironov asked Township Manger if funds are available to pay these salaries or if transfers were needed. Township Manger stated the only transfer needed would be to transfer Public Works to Maintenance from the Senior Center salaries. Mayor Mironov stated the \$55,000 will be made available and sign off by the Mayor the following day, and further proposed one single transfer under Resolution R2012-225.

It was MOVED by DUKE and seconded by ROSENBERG that Resolution R2012-225 be approved as revised, removing all resolution items and including only to Public Works road repair salary and wages of \$10,000 from Public Works Senior Center salary and wages, for a total of \$10,000.

Mayor Mironov stated she and Mr. Rosenberg attended two DARE graduations one on Monday evening, December 3, at the Rogers School and one this morning, December 4, at the Drew School. Mayor Mironov stated as a reminder that Womenspace Communities of Light event will be held on December 10, at 5 pm at the Municipal Building. Mayor Mironov also stated she visited the Riviera at East Windsor which held a drive for Super Storm Sandy victims, and stated they collected items of necessity and raised over \$4,000 and over 200 bags of donations in a short period of time. Mayor Mironov is in receipt of a letter dated November 26, from Mercer County regarding the replacement of County Bridge. The Turnpike indicated the start of the detour to complete bridge work linking to Route. 133, and will be starting on or about December 10. More information will be forthcoming through the Township E-News. Mayor Mironov noted she requested information regarding the letter from DeGeorge.

Mayor Mironov stated there was a discussion item on the previous Council meeting regarding Escrow Ordinances and that Mayor and Council directed staff to meet and discuss theses, and to update Mayor and Council; however no update was provided to the Mayor. Mayor Mironov directed the Township Manager to setup a meeting and to update the Mayor. Mayor Mironov stated the Enchantment account appears to have inconsistencies and requested clarification as to how this would be resolved between the Township Manager and Attorney as to the correct account. Township Manager stated to Mayor and Council that he will discuss and resolve this issue with the Township Attorney. Mayor Mironov directed to receive a vebal response regarding the results the next day. Mayor Mironov stated the she was in receipt of the schedule regarding the Bond Anticipation note closing on December 11, 2012, the notices were complete, and bid sales were to be received today.
