Mayor Mironov stated the Economic Committee met on October 4, and continued to review a new marketing brochure for the Township, and further discussed plans for an event with the Princeton Chamber of Commerce

APPROVAL OF BILLS:

Mayor Mironov asked if there were questions on any bills. Mayor Mironov directed the Township Manager to correct a bill, and noted the receipt of a memo from the Public Works Director regarding a new garbage collection vehicle.

Mayor Mironov stated the success of Recycling Day held on October 6, and noted the Flu Clinic ends October 17.

The Township received a letter from the Surrogate's office dated October 1, with the proposed list of satellite office dates for 2013 and is under review for final approval. The Council received a Tax Collector report of Receipts and Reimbursements for period ending September 30, 2012.

The Township received a letter from the New Jersey Turnpike Authority indicating the closure and detour at the intersection of Route 133 and 33, originally scheduled for on or about September 24, has been rescheduled on or about November 5.

Mayor Mironov stated Mayor and Council are awaiting an offset for Resolution R2012-202 that was approved at the previous Council meeting.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. Shared Services Agreement with West Windsor Township for Animal Control

The Township received a letter dated September 24, 2012, indicating their desire to renew the Shared Services agreement for the years 2013 and 2014. Mayor Mironov directed the Police Chief to prepare material with potential agreements, and the Council is in receipt of this material. The Mayor further requested she and Chief Monahan be authorized to negotiate this agreement with West Windsor for 2013 and 2014, and return to the Council for review and approval. The Mayor stated the previous agreement yielded positive cost-benefit results for the Township.

Mr. Lippman and Mr. Rosenbeg stated the advantageous nature of this agreement. Mayor and Council were in unanimous agreement to continue this agreement and authorized the Mayor and Police Chief to negotiate an Agreement for Council review and approval.

2. Restoration of Municipal Energy Tax Receipts

Mayor Mironov reminded everyone that on Thursday, October 18 at 7 pm at the East Windsor Senior Center, a taxpayer forum on this subject would be sponsored by G.E.T R Money Back, and headed by Helene Henkel to educate the public on this issue and allow residents to ask questions. The Mayor listed the confirmed participants to be Mayor Mironov, Mayor Steve Kirsen of Hightstown, and Mayor Anthony Fiore of Middletown Township. She further stated this is one of the means by which property tax relief can be immediately provided to residents in our State, and has bipartisan support in both the State Senate and Assembly

Mr. Rosenberg stated his support of the forum and of the Mayor's leadership regarding this topic.

There being no further business Mayor Mironov adjourned the meeting at 8:15 p.m.
