In the fourth paragraph, she asked that the wording "since the purchase is under \$17,500, public bids are not required as set forth in N.J.S.A. 40A:11-4 requiring public advertising and bidding for contracts for a sum exceeding the aggregate amount as calculated periodically by the Governor, pursuant to N.J.S.A. 40A:11-3 which amount is \$17,500; and" be inserted and in a seventh paragraph add "the maximum amount of the purchase and installation of new Firewall is \$2,934...".

Mayor Mironov asked that on page 1 of the contract cross out what is not being purchased and the same on page 2. She asked for clarification on the 3-year subscription on whether it is part of the cost.

Mayor Mironov reported that the East Windsor Economic Development Committee met on May 8, they are looking at an event at the end of the summer maybe in partnership with Mid-Jersey Chamber of Commerce to promote the Einstein Alley. They are looking to participate in the Princeton Regional Chamber of Commerce Regional Convention Visitor Bureau.

## **APPROVAL OF BILLS:**

Mayor Mironov said that there is a Current 2014 and Current 2013 bill list, 1 page Capital bill list and some other misc. and trust fund account bill lists all dated May 15, 2014.

Council Member Shapiro would like clarification why there are a lot of auto parts bills on this bill list and wants to know if this is standard procedure. Mr. Brady stated that these bills were held due to the temporary budget and can be paid now that the budget has been appropriated.

Mayor Mironov asked that on the Capital bill list, that the Arbor Day Foundation be pulled. She questions the account that it is charged to. She would like clarification on the Current 2014 bill list, page 4, the Police Training as to where the expectation is going to be on this cost. She doesn't want this pulled just clarification.
