#### **ORDINANCE – PUBLIC HEARING:**

Ordinance No. 2015-06 Bond Ordinance Providing for Various Capital Improvements in and by the

Township of East Windsor, in the County of Mercer, New Jersey,

Appropriating \$900,000 therefor and Authorizing the Issuance of \$570,000

Bonds or Notes of the Township to Finance Part of the cost Thereof

The Municipal Clerk read by title Ordinance No. 2015-06. Mayor Mironov stated the Ordinance had been introduced on May 19. Mayor Mironov then declared open the public hearing.

Sean O'Connor, 152 Hickory Corner Road, inquired about grant funding and road maintenance.

As no further members of the public wished to be heard, Mayor Mironov declared closed the public hearing.

Mayor Mironov stated that \$300,000 in grants had been received for Dorchester Drive improvements and that other grant applications for roadway improvements were pending. She also asked for an updated schedule from staff for these improvements.

## **ORDINANCE 2015-06**

BOND ORDINANCE PROVIDING FOR VARIOUS ROAD IMPROVEMENTS IN AND BY THE TOWNSHIP OF EAST WINDSOR, IN THE COUNTY OF MERCER, NEW JERSEY, APPROPRIATING \$900,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$570,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST WINDSOR, IN THE COUNTY OF MERCER, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Township of East Windsor, in the County of Mercer, New Jersey (the "Township") as general improvements. For the several

improvements or purposes described in Section 3, there are hereby appropriated the respective

sums of money therein stated as the appropriation made for each improvement or purpose,

such sums amounting in the aggregate to \$900,000, including a \$300,000 grant expected to be

received from the State of New Jersey Department of Transportation Municipal Aid Program for

capital road improvements to Dorchester Drive, as described in Section 3(b) (the "State Grant")

and further including the aggregate sum of \$30,000 as the several down payments for the

improvements or purposes required by the Local Bond Law. Pursuant to N.J.S.A. 40A:2-11(c),

no down payment is provided for the costs of the improvements to be funded from the State

Grant. The amount of the down payment appropriated is 5% of the \$600,000 in costs of the

improvements which are not to be funded by the State Grant. The down payments have been

made available by virtue of provision for down payment or for capital improvement purposes in

one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not

covered by application of the several down payments and the State Grant, negotiable bonds are

hereby authorized to be issued in the principal amount of \$570,000 pursuant to the Local Bond

Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby

authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for

which the bonds are to be issued, the estimated cost of each improvement and the

appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each

improvement and the period of usefulness of each improvement are as follows:

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief

financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements or purposes that the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

- (b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 10.00 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$570,000, and the obligations authorized herein will be within all debt limitations prescribed by that Law.
- (d) An aggregate amount not exceeding \$125,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements.
- Section 7. The Township hereby declares the intent of the Township to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.
- Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or, if other than the State Grant, to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Township is hereby authorized to prepare

and to update from time to time as necessary a financial disclosure document to be distributed

in connection with the sale of obligations of the Township and to execute such disclosure

document on behalf of the Township. The chief financial officer is further authorized to enter

into the appropriate undertaking to provide secondary market disclosure on behalf of the

Township pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for

the benefit of holders and beneficial owners of obligations of the Township and to amend such

undertaking from time to time in connection with any change in law, or interpretation thereof,

provided such undertaking is and continues to be, in the opinion of a nationally recognized bond

counsel, consistent with the requirements of the Rule. In the event that the Township fails to

comply with its undertaking, the Township shall not be liable for any monetary damages, and the

remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Township are hereby pledged to the punctual

payment of the principal of and the interest on the obligations authorized by this bond ordinance.

The obligations shall be direct, unlimited obligations of the Township, and the Township shall be

obligated to levy ad valorem taxes upon all the taxable real property within the Township for the

payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication

thereof after final adoption, as provided by the Local Bond Law.

It was MOVED by Shapiro and SECONDED by Duke that Ordinance No. 2015-06 be adopted and

authorized for publication as required by law.

**WHEREAS,** New Jersey is home to a rich diversity of wildlife and ecologically significant natural communities; and

**WHEREAS,** New Jersey's wildlife and wild places are under threat from development, fragmentation, invasive species and the impacts of people; and

**WHEREAS**, the populations of mammals, birds, invertebrates, fish, reptiles and amphibians that live in and migrate through New Jersey find themselves clinging to smaller and smaller pieces of wild clean lands and aquatic habitats; and

**WHEREAS,** it is more cost-effective to prevent species from becoming imperiled than it is to recover them once their populations have declined; and

**WHEREAS,** a naturally functioning and healthy ecosystem represents a healthy environment for New Jersey wildlife and our citizens; and

**WHEREAS**, the New Jersey Division of Fish and Wildlife, other state and federal agencies, and many partners in conservation have worked together to develop a state Wildlife Action Plan for the benefit of biologists, wildlife experts, municipal leaders, land stewards, non-profit organizations, educators, planners, researchers, outdoor recreation enthusiasts, landowners and all the people who know the wild places of New Jersey State; and

**WHEREAS,** the New Jersey Wildlife Action plan is a comprehensive action agenda for the conservation of native wildlife, the restoration of important lands and water, and public education targeting the needs of rare wildlife in New Jersey; and

**WHEREAS**, the residents of and visitors to New Jersey also enjoy and benefit from New Jersey's wildlife and wild spaces;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, that:

- 1. East Windsor Township resolves to take the following steps with regard to our municipal land-use decisions with the intent of making East Windsor an ecologically sustainable community. It is our intent to include these principles in our public lands management, our environmental resources inventory and to inform the next master plan revision and update our zoning accordingly.
  - a. Identify imperiled species, critical habitat and unique ecosystems in our Environmental Resource Inventory.
  - b. Acknowledge that it is more cost-effective to protect species than recover species, we will protect populations of rare and imperiled species that live and breed in, and migrate through, the municipality and the habitats they depend upon.
  - c. Because habitat integrity is critical to healthy biodiversity, manage publicly owned lands in accordance with wildlife management actions laid out in the New Jersey Wildlife Action Plan and will promote the management of all protected lands to promote biodiversity.
  - d. Seek to protect wildlife habitats and maintain connectivity of habitat when formulating an open space acquisition strategy, open space stewardship plans and through the municipal master plan including planning and zoning ordinances.
  - e. Seek to minimize disturbance of critical wildlife populations and their habitats from human activities, subsidized predators and invasive species.
  - f. When possible and appropriate, work with neighboring municipalities to implement the aforementioned principles across municipal boundaries.
  - g. When possible and appropriate, strive to monitor and implement appropriate management of municipal easements to ensure native vegetation and wildlife takes precedence over invasive and/or exotic species.

Mayor Mironov stated there was information in Council Members' folders regarding a Sustainable Jersey filing that showed all action items had been followed through.

## DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

## 1. East Windsor Township Website Update

Mayor Mironov stated an outside company had been retained to handle the design and technical aspects of the new website. In addition, a committee had been formed internally consisting of Mayor Mironov, Council Member Yeager, the Township Manager, the Recreation Director, a staff member from the Public Works Department, the Municipal Clerk that had met regularly had had conference calls with the vendor. The committee had been reviewing the new website design and it remained a work in progress. The goal was to have a more user-friendly website that will facilitate the dissemination of information. The committee had also been identifying documents that should be placed on the website, such as planning documents, forms, and so forth. Also, all information on the current site would be migrated to the new site, and there would be a training process for staff. It was expected that the new site would be presented to Council over the summer.

Council Member Yeager noted that the new site was a major undertaking and expressed his thanks for the staff that had worked on it. He was looking forward to a new site that not only looked great, but was also very functional.

Mayor Mironov explained that the menus would be restructured, and the website would be much easier to navigate.

## 2. Fence Replacements for Wiltshire Park and Veterans Park

Mayor Mironov stated Council had to determine whether the fences needed replacing and, if so, what kind of material should be used for replacement.

The memo provided offered two options: chain link or post and rail. Mayor Mironov noted it did not have to be the same fence in both parks. Council Member Shapiro stated most of the rail fence was a concern in Veterans Park. One side had sturdy fencing, but the other side had falling fences. However the materials seemed solid and might be re-used if the posts were replaced. He stated the chain link on other portions surrounding the field was not aesthetically pleasing. He believed the Township should do whatever is safest and was not opposed to chain link.

Mayor Mironov stated the fence at Wiltshire provided a separation, privacy and security from residential homes. A fence had always been in place at this location.

Mayor Mironov noted that, based on the comments on Veterans Park, this issue should be held over for further research to see if the fencing can be repaired/re-used rather than replaced.

Mayor Mironov suggested that the fencing at Wiltshire Park should be replaced. She had discussed this with the Public Works Director, and quotes had been obtained. There had been some discussion

regarding whether it should be done internally or by a contractor, depending on cost. Because the quotes were reasonable, she was recommending an outside company replace it. Council Members agreed unanimously.

Mayor Mironov stated Veterans Park should be removed entirely from Resolution R2015-105 and that the contract should indicate the fall installation of the fence at Wiltshire by Horner Brothers in an amount not to exceed \$6120. The CFO certification would need to be adjusted.

**WHEREAS**, the Township Council has reviewed the Public Works Department recommendations on said purchase; and

**WHEREAS**, the maximum amount of the purchase is \$6,120.00 and funds are available in Account No. C-04-55-953-914-505 entitled Ordinance 2013-09 Parks & Playgrounds in the amount of \$870.00 and in Account No. C-04-55-970-916-870 entitled Ordinance 2015-02 Parks & Playgrounds in the amount of \$5,250.00 as evidenced by the Chief Financial Officer's Certification No. C2015-016.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

1. The Township Council authorizes the contract with Horner Brothers for the installation of chain link fence for Wiltshire Park for an amount not to exceed \$6,120.00 in accordance with their quote.

## 3. East Windsor Township Open Space and Recreation Plan Updates

Mayor Mironov stated the revised plan and information was in Council Members' folders that evening. The revised Open Space Plan removes open space parcels that had been acquired since the last amendment, and that information had been provided to Council showing how the new information had been calculated. She noted the Plan was a requirement for Green Acres Acquisition Grants, such as the one that had assisted in the purchase of 181 Airport Road that year. These purchases enabled the Township to preserve open space and protect native wildlife, as well as balance land use that makes East Windsor a desirable place to live. Some open space acquisitions had provided buffers that reduced flooding in some communities and improved home values. She noted the Township's Recreation and Open Space Inventory had also been updated. Properties had been purchased on an individual basis at a point when it was feasible and made sense. The Township had used County and Green Acres grant funding, as well as developers' trust fund monies.

Council Member Yeager added that the goals and policies in the Plan were consistent and had not changed since the Plan had originally been adopted. Council Member Shapiro added that the Township had not purchased certain lands that had been available as they did not meet East Windsor's goals for the Township and the environment. Council Member Rosenberg noted that the Township's Open Space Plan was consistent with residents' wishes as well. Council Member Zoller commented how important farmland preservation was to local farmers and the Township.
