The Municipal Clerk read by title Resolution R2015-108. Mayor Mironov read the resolution in its entirety. Mayor Mironov issued the Proclamation to the representatives from businesses in East Windsor who attended the meeting to support and sign the We Check 21 pledge. Mayor Mironov spoke of the importance of checking the identifications of customers buying alcohol to make sure that it does not end up in the hands of minors. Council Member Yeager assisted Mayor Mironov with distributing materials and making sure the pledges were signed.

**WHEREAS**, on January 12, 2012 the Township acquired the property commonly known as the Skeba property, and designated on the East Windsor Township Tax Maps as Lot 12 in Block 30 ("the Property"), for use as open space; and

**WHEREAS**, at the time of acquisition, the description of the Property reflected a right of way dedication along Etra Road to be conveyed to the County of Mercer; and

**WHEREAS**, the Township and the County of Mercer have agreed that this right of way should be conveyed at this time;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey as follows:

I

- 1. The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached Right of Way Dedication deed to the County of Mercer for part of Lot 12 in Block 30.
- 2. The Municipal Clerk is directed to deliver the fully executed Right of Way Dedication to the County of Mercer for recording.

# II REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

# III SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

# IV EFFECTIVE DATE

This Ordinance shall take effect 20 days after final passage and publication according to law.

**WHEREAS**, the grant agreement for federal financial assistance will impose certain obligations upon New Jersey Transit, which will, in turn, be imposed upon all sub-recipients; and

**WHEREAS**, East Windsor Township as a sub-recipient has or will provide all annual certifications and assurances for the project to transit, as required by the Federal Transit Administration's policies governing pass through agreements.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached grant agreement with New Jersey Transit to provide grant funding from July 1, 2015 through June 30, 2016.
- 2. The Township Manager is hereby authorized and directed to file with New Jersey Transit annual certifications and assurances and other documents New Jersey Transit requires, in accordance with the Federal Transit Administration requirements for awarding federal assistance via a pass through agreement.

The Municipal Clerk read by title Resolution R2015-114. Mayor Mironov stated the Township held a pro-active process to award this contract. An RFP was sent to a list of firms and was publicly posted on the Township's website. A committee had been appointed consisting of Mayor Mironov, Council Member Shapiro, the Township Manager and the Township Attorney. The committee had reviewed the proposals, interviewed several firms, and made a recommendation. The criteria was based on experience and reputation, experience with affordable housing programs, knowledge of the Township, the firm's fee proposal, and other factors, if demonstrated to be in the interest of the Township, as determined at the discretion of the East Windsor Township Mayor and Council. The committee's recommendation had been unanimous and Parker McCay would be paid through the East Windsor Township Affordable Housing Trust Fund rather than from the Municipal Budget. She noted Ronald Morgan of Parker McCay had years of experience and an excellent reputation representing towns throughout the State. Parker McCay was a large firm with 50 to 100 employees. Mayor Mironov further stated East Windsor reviewed invoices very closely before payment was approved. Mr. Morgan was being hired hourly, not on retainer and would be paid based on work performed. He was also being authorized to represent East Windsor in court to protect the Township.

Council Member Shapiro commented that Mr. Morgan's knowledge of a convoluted issue was astounding, and that it was critical that the Township retained a knowledgeable attorney to represent it.

Council Member Rosenberg stated that the Council reviewed the Bills List prior to approving it at each Council meeting.

Mayor Mironov asked that "Township Manager in the sixth paragraph be replaced with "committee's."

**WHEREAS,** on December 15, 2008, the Township of East Windsor and its Planning Board adopted and endorsed a third round Housing Element and Fair Share Plan (collectively "Compliance Plan") based upon the existing third round rules and methodologies that were adopted by the New Jersey Council on Affordable Housing ("COAH") as codified at N.J.A.C. 5:96 and 5:97; and

**WHEREAS,** the Appellate Division invalidated the COAH rules which decision was upheld by the Supreme Court on September 26, 2013 in <u>In re Adoption of N.J.A.C. 5:96 & 5-97 by the Council on Affordable Housing</u>, 215 N.J.578 (2013); and

**WHEREAS,** the Supreme Court remanded the case to COAH to promulgate new third round rules; and

**WHEREAS,** COAH failed to adopt such new rules, which resulted in judgment enforcement proceedings before the Supreme Court; and

WHEREAS, the Supreme Court issued a decision and Order on March 10, 2015 which divested COAH of further rulemaking and administrative review authority and determined that the Court be the forum for ensuring municipal affordable housing compliance and crafted a procedure for municipalities that participated in the COAH review process to retain repose and immunity against builder's remedy litigation and exclusionary zoning challenge while seeking to address their third round fair share obligation; and

**WHEREAS**, the Township of East Windsor wishes to retain its repose and immunity against builder's remedy litigation and exclusionary zoning challenges and hereby authorizes the attorney to file declaratory judgment proceedings with the Court on or before July 8, 2015.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, that:

1. The Township Affordable Housing Attorney and Planning Consultant are hereby authorized and directed to file declaratory judgment proceedings with the Court pursuant to the March 10, 2015 Supreme Court decision.
