TOWNSHIP OF EAST WINDSOR MERCER COUNTY, NEW JERSEY

ORDINANCE NO. 2016-05

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Council of the Township of East Windsor in the County of Mercer finds it advisable to permit an increase of its CY 2016 budget by up to 3.5%, if necessary, over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Council hereby determines that a 3.5 % increase in the budget for said year, amounting to \$630,845.88 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Township Council hereby determines that any amount authorized herein that is not appropriated as part of the final CY 2016 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey as follows:

I

- 1. In the CY 2016 budget year, the final appropriations of the Township of East Windsor shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$630,845.88, and that the CY 2016 municipal budget for the Township of East Windsor be approved and adopted in accordance with this ordinance; and,
- 2. Any amount authorized herein that is not appropriated as part of the final CY 2016 budget shall be retained as an exception to final appropriations in either of the next two succeeding years.
- 3. A certified copy of this ordinance as introduced shall be filed with the Director of the Division of Local Government Services within 5 days of introduction.
- 4. A certified copy of this ordinance upon adoption, with the recorded vote included thereon, shall be filed with said Director within 5 days after such adoption.

II REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

III SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

IV EFFECTIVE DATE

This ordinance shall take effect twenty (20) days after the final passage and publication as required by law.

Resolution R2016-056 Adoption of the 2016 Municipal Budget

The Municipal Clerk read by title Resolution R2016-066. Mayor Mironov stated the Municipal Budget had been introduced on March 22, 2016 and at that time the public hearing was set for April 19, 2016. The Township Auditor Frances "Bud" Jones and Finance Director Laurie Finger were present to field any questions that might arise. Mayor Mironov declared open the public hearing. As no members of the public wished to be heard, Mayor Mironov declared closed the public hearing. Mayor Mironov inquired of the Township Auditor and Finance Director whether approval of the budget, as is, had been approved by the State. Both answered in the affirmative that State approval had been received. Mayor Mironov stated that the budget being adopted is the identical budget that was introduced and it provides no tax increase for the year 2016, representing the third year in a row that the municipal budget contains no tax increase, meaning the rate has been identical for 2016, 2015, 2014, and 2013 – 43 cents per hundred dollars of assessed valuation and again remains the smallest part of the total property tax bill and averages around 15% of the total tax bill. Putting the budget together based on a foundation of prior year was difficult and Mayor Mironov expressed thanks to Laurie Finger, Finance Director and James Brady, Township Manager for their important work as well as other departments for their input and meetings with the Council on this conservative budget that meets the needs and expected service levels of this community.

WHEREAS, mutual aid and assistance agreements between municipalities, counties, law enforcement agencies, police, EMS, fire companies or EMS organizations and fire departments situated in fire districts operated by a Board of Fire Commissioners, are permitted, pursuant to N.J.S.A. 40A: 14-26 and 40A: 14-156.1; and,

WHEREAS, the President of the United States in Homeland Security Directive (HSPD-5), the development and administration of a National Incident Management System (NIMS) which would provide a consistent nationwide approach to Federal, State, local and tribal governments to work together more efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size or complexity; and,

WHEREAS, "The New Jersey Civilian Defense and Disaster Control Act", N.J.S.A. app. A:9-33 et. seq, provides for the health, safety and welfare of the people of the State of New Jersey during any emergency by centralizing control of all civilian activities having to do with such emergency giving the Governor control over the resources of each and every political subdivision to cope with any condition that shall arise out of such emergency; and,

WHEREAS, the Director of the Division of Fire Safety in the Department of Community Affairs promulgated rules in accordance with the "Fire Service Resource Emergency Deployment Act," N.J.A.C. 52:14E-11 et. seq., commonly referred to as the "Fire Service Resource Emergency Deployment Regulations" N.J.A.C. 5:75A et. seq.; and,

WHEREAS, it is deemed to be in the best interests of the residents of Mercer County to enter into a mutual aid and assistance agreement with municipalities in Mercer County to include but not be limited to, emergency management, emergency medical service, fire service, government administrative, government electrical and construction inspection services, hazardous materials, health care, law enforcement, public communications, public health, and public works personnel, to provide additional protection against loss and aid in recovery from, damage or destruction by fire, catastrophe, civil unrest, major emergency or other extraordinary devastation, damage or destruction to person and property, in those situations when outside aid and assistance is needed; now, therefore,

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. That the Mayor and Municipal Clerk are hereby authorized to execute said Mutual Aid and Assistance Agreement between the County of Mercer and municipalities and jurisdictions participating throughout Mercer County to provide services in the event of a large scale emergency or disaster, with a term expiring on December 31, 2020; and,
- 2. That the Municipal Clerk shall forward (3) certified copies of the Resolution and three (3) copies of the Agreement to the Mercer County Office of Emergency Management.

WHEREAS, there exists a need for additional engineering consulting services regarding the environmental constraints of properties known as Block 46, Lots 1 and 2, in connection with the Township acquisition of Lot 1 and Rights-of-Way acquisition through Lot 2 for the Route 130/Hankins Road/Conover Road Intersection Realignment Project; and

REPORTS BY COUNCIL AND STAFF:

Council Member Rosenberg reported on the Clean Communities meeting held on March 24, where the April 16th Recycling Day, the April 23rd Spring Clean-Up, and the April 30th Operation Medicine Cabinet were all discussed.

Council Member Yeager reported that the Municipal Alliance met on April 13th and discussed some work being done on a brochure and third quarter reporting. The Recreation Committee also met on April 13th and discussed the recently held 5K Run/Walk, the upcoming summer camps and planned summer events.

Council Member Shapiro reported on the previous evening's Planning Board meeting where the application for One Mile Storage was heard and is being continued.

Council Member Zoller reported on the Economic Development Committee meeting held on April 7th where Township promotional materials and Gateway signs were discussed.

Council Member Daniels reported on the March 24th Commission on Aging meeting where discussion was had about building maintenance.

Council Member Rosenberg remarked about the success of the 5K Run/Walk.

Mayor Mironov spoke about a volunteer appreciation event held for the individuals who volunteer for the Senior Center. Mayor Mironov also wished to make it a matter of public record as a follow-up to the previous Council meeting that the contract for the solar project was made available to all Council Members to give all time to respond to the Manager with any comments of which there were none.

CORRESPONDENCE:

Mayor Mironov announced correspondence received from Mercer County dated April 8th that work will be commencing on Ward Street on Monday April 25th between Etra Road and Davison Road. Information on that has already been put out in the e-news and the Township website.

In other County correspondence dated April 18th, there is going to be a project on Old York Road between the New Jersey Turnpike overpass to Herbert Road.

With respect to a comment made by Mr. Zoller at a prior meeting, the Mayor indicated that Mercer County was going to be doing work on the bridge on Old Trenton Road, but it will not likely be until sometime next year and all will be kept posted.

Mayor Mironov stated that a letter was received from Comcast indicating that they will be opening a new X-finity store in Lawrence to provide upgraded customer service and will close the smaller front counters in Trenton, Lambertville and East Windsor on or about May2, 2016. Mayor Mironov expressed annoyance at this news, describing it as very poor customer service with the significant rates being charged for their services. The current location is adjacent to a major part of the East Windsor community which has a bulk agreement with Comcast for service. Mayor Mironov did place a call to the author of the letter but has not heard back yet and a copy of the letter was sent to the Twin Rivers Trust as well. Mr. Zoller expressed concern over this closing. Mayor Mironov requested authorization to send out an immediate letter indicating that East Windsor is extremely disturbed by this surprise and that this is not considered to be a well-based decision and would like the matter reconsidered. Council Member

Rosenberg spoke regarding the need to sometimes exchange equipment at the Comcast office which will now be made more difficult. Mayor Mironov read from the correspondence, Comcast claims that customers have other options to pay bills, such as online or from an app. With regard to the drop off of equipment, there is availability of bringing the equipment to U.P.S. stores and to have it delivered to Comcast at no charge and Comcast will ship equipment to customers for a shipping fee. Ms. Daniels commented on the hardship and inconvenience to residents of the Twin Rivers area that may not have vehicles to get to the new Lawrence office.

It was MOVED by Yeager, SECONDED by Lippman to reply to Comcast, per the Mayor's comments, as quickly as possible.

Mayor Mironov indicated that a memo had been received from the Public Works Director on this matter, separating the various categories and making comments. Mayor Mironov explained the categories and suggested that Resolutions authorizing submission of applications for the grant be listed on the next Council meeting agenda. Council Members concurred with this approach.

2. East Windsor Bicycle Safety Program

Mayor Mironov stated that a \$10,000 grant has been received to fund this program, which has three phases 1. Bike Helmet Giveaway; 2. Mock summons program recognizing young people wearing helmets; and 3. Bike at Night, Use a Light. Council Member Yeager spoke to the importance of all phases of the program and suggested continuance of the program. Council Member Zoller expressed the importance of the use of bicycle lights. Mayor Mironov and Chief Marshall will coordinate dates for the three phases.
