BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EAST

WINDSOR in the County of Mercer, State of New Jersey, as follows:

SECTION 1. Ordinance 2016-09, entitled, "An Ordinance Amending and Supplementing Chapter XX, 'Zoning', Subsection 20-5.1604b. 'Prohibited Signs' and Subsection 20-5.1607a.5. Under Subsection 20-5.1607, "Sign Regulations for Each Zoning District", of the Revised General Ordinances of the Township of East Windsor" is hereby rescinded and repealed in its entirety.

SECTION 2. All ordinances or parts thereof which are inconsistent or conflict with the provisions of this ordinance or any part thereof are hereby repealed to the extent of said inconsistency or conflict.

SECTION 3. This ordinance shall take effect twenty (20) days after the final adoption, publication and in accordance with law.

Mayor Mironov announced that this Ordinance was introduced on September 20, 2016 and declared the public hearing open regarding Ordinance 2016-11 and with no comment from the public being made, declared closed the public hearing.

Mayor Mironov stated that this had been carried from the previous Council meeting in order to get more definitive information regarding the amount. The amount we agreed upon to participate with other municipalities in this matter is \$1,000. However, Mayor Mironov recommended to provide for that amount but also to allow an amount to go up to \$5,000 should there be additional work needed, that could be administratively approved by the Township Manager and herself without requiring further Council action.

WHEREAS, the Supreme Court issued a decision and Order on March 10, 2015, divesting the New Jersey Council on Affordable Housing (COAH) of further rulemaking and administrative review authority and determining that the Court be the forum for ensuring municipal affordable housing compliance and crafting a procedure for municipalities that participated in the COAH review process to retain repose and immunity against builder's remedy litigation and exclusionary zoning challenge while seeking to address their third round fair share obligation; and

WHEREAS, on June 23, 2015, by the approval of Resolution R2015-115, the East Windsor Township Council authorized the filing of a Declaratory Judgment legal action with the Court, pursuant to the March 10, 2015 Supreme Court decision; and

WHEREAS, reports (initial reports), that have been filed with the Superior Court, Law Division, Ocean County and with Superior Court of New Jersey, Law Division, Mercer County, for Region 4 municipalities located within Mercer, Ocean and Monmouth counties that filed declaratory judgment actions, have been prepared by Nassau Capital Advisors, LLC which analyzed the financial and economic constraints and limitations of inclusionary zoning strategy as a public policy in satisfying prospective need for low and moderate income households in Mercer County through the year 2025; and

WHEREAS, Nassau Capital Advisors, LLC, has agreed to provide the initial reports, with data sets broken down by county, to the participating Region 4 municipalities for a total cost of \$16,500 with each municipality's proportionate share to be \$1,000; and

WHEREAS, further research, reports and/or testimony may be necessary from Nassau Capital Advisors, LLC in this matter.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The attached Agreement with Nassau Capital Advisors, LLC, is approved.
- 2. The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached Agreement with Nassau Capital Advisors, LLC.
- 3. An amount of \$1,000 is approved for East Windsor Township's share of the cost for the initial reports.
- 4. An additional amount of up to \$4,000 is hereby authorized to be expended, upon administrative approval by the Township of East Windsor, if further necessary research, reports and/or testimony becomes necessary in connection with the Township Declaratory Action.
- 5. The maximum total amount of the expenditure is \$5,000 and funds are available in the Account No. A-22-56-852-852 entitled Affordable Housing, as evidenced by the Chief Financial Officer's Certification No. T2016-014.

Also on September 22, the Clean Communities Committee, Mayor Mironov and Mr. Rosenberg presented a certificate of recognition as a litter-free business, to Knowledge Beginnings for the way their business and property is maintained. Mr. Rosenberg also stated that the Commission on Aging met and discussed full attendance at the various classes.

Council Member Shapiro reported that the Environmental Commission met at Etra Lake Park and discussed the various trees in the park and the health of those trees. Mayor Mironov stated that the Township's five year Forestry Management Plan has been approved by the State. Mr. Shapiro also reported that the Planning Board met on September 26 and considered approval of an outdoor waiting area for Galleria at Twin Rivers.

CORRESPONDENCE: None

APPOINTMENTS: Were done earlier in the meeting.

APPROVAL OF BILLS:

Mayor Mironov specified the various bill lists and trust fund lists presented for payment.

Council Member Zoller questioned the very last bill on page 10 of the Current 2016 bill list for animal control. Mr. Zoller inquired about Township policies regarding the bill and asked that it be held pending clarification.

Mayor Mironov asked that the first bill on page three of the Current 2016 bill list be held and also asked that confirmation be received that the website company has completed all tasks in their contract before finalizing payment.

It was MOVED by Shapiro, SECONDED by Daniels to approve the presented Bill Lists with the exceptions.

There being six (6) ayes and no (0) nays the various presented Bill Lists with the exceptions were approved.

MATTERS BY COUNCIL:

Mayor Mironov stated that Council has received a copy of the Egg Hunt notice from Recreation and that Budget memos have been received from the Manager. Mayor Mironov also announced that the annual Flu Clinics have been scheduled. Mayor Mironov also reported receipt of a copy of an application from Mercer County to the Delaware Valley Regional Planning Commission for a local concept development study traffic issues in the vicinity of Old Trenton Road and Princeton Hightstown Road. This will be a first phase of what will hopefully be intersection improvements funded under the Federal Highway Safety Improvement Program.

DISCUSSION ITEMS AND COUNCIL ACTION WHERE APPROPRIATE:

1. East Windsor 2017 5K Walk/Run Proposal

Mayor Mironov stated that the Recreation Director has distributed the proposal of what has thus far been discussed with the Commission on the event. Deputy Mayor Yeager stated that the Commission did meet and discuss the event as well as how successful this year's event was and how it could be expanded upon. Council is in agreement for the Recreation Department to continue in its planning and keep Council apprised of its progress.

2. East Windsor Senior Center Maintenance Work for Painting and Wallpapering

Mayor Mironov indicated that this had been discussed at the last Council meeting on September 20 and requested some follow-up from Public Works, which has not been received. Council in consensus that this matter must be addressed and is looking to see follow-up from The Public Works Director on their previous requests.

3. Route 130/Hankins Road/Conover Road Realignment Improvement Project

Mayor Mironov stated that there are a few things pending in this matter. The Township Attorney will be getting us paperwork pertaining to the right-of-way acquisition, hopefully for the next Council meeting. It appears that an agreement has been reached on the State Transportation Trust Fund which would lift the stop work orders and clear the way to move forward on this project. The Public Works Director was supposed to get an update on Robbinsville's right-of-way acquisitions and the Public Works Director is again requested to follow-up. Council in agreement that this should be done. Council Member Rosenberg suggested that it might be helpful for the Public Works Director to attend a Council meeting so it could be explained the Council as to the status of this project. Mayor Mironov stated the Public Works Director was also to be following up on three items the N.J.D.O.T. had requested, which are signed and sealed plans, signed and sealed specifications for bidding, and the signed and sealed Engineer's estimate for the project. Mayor Mironov informed Council of previous actions taken to get these items ready for when the State is ready to move forward.
