Mayor Mironov stated that this matter was discussed at the last Council meeting and determined that East Windsor would proceed in this manner. Mayor Mironov also indicated that current coverage expires at the end of this year so it is important that action be taken at this time. Mayor Mironov asked that the action on this matter be conditioned as there are questions pertaining to whether a 2017 membership proposal has been reviewed and whether there are any concerns or changes, whether the attached by-laws have been reviewed for changes, what 2017 costs will be and where exactly they are formally stated, what the four enhancements are to existing coverage, and what the broker fees are and when and how they will be paid.

## RESOLUTION R2016-221 EAST WINDSOR TOWNSHIP MERCER COUNTY

**WHEREAS**, the Township of East Windsor has participated as a member of the Middlesex County Municipal Joint Insurance Fund (hereinafter the "Fund") existing pursuant to Chapter 372, Laws of 1983 (N.J.S.A. 40A:10-36 et seq.) and is desirous of continuing said membership with the term expiring December 31, 2019; and

**WHEREAS**, the Township Council of the Township of East Windsor has determined that continued membership in the Fund is the best interest of the Township.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer and State of New Jersey, as follows:

**SECTION 1.** The Township of East Windsor hereby agrees to continue as a member of the Fund for a period of three (3) years commencing January 1, 2017 and terminating on December 31, 2019 for the purpose of securing the following types of insurance coverage:

- (a) Workers Compensation and Employers Liability
- (b) General Liability Coverage (including Public official, Police Professional)
- (c) Motor Vehicle and Equipment Liability Coverage
- (d) Property Damage Coverage (including Building & Contents, Automobile, Physical Damage, Contractors Equipment, and Boiler and Machinery and Public Employee Blanket Bonds)

After the expiration of the said three (3) year period membership, participation may be cancelled or extended in accordance with the By-Laws of the Fund.

**SECTION 2.** For the purposes of contribution of sums into the Fund to be designated for administrative costs and claims, the Township of East Windsor hereby agrees to obtain the types of coverage from the Fund as set forth in Section 1 of this Resolution and the Indemnity and Trust Agreement to be signed by it.

**SECTION 3.** The Bylaws of the Middlesex County Municipal Joint Insurance Fund, attached hereto, are hereby adopted and accepted.

**SECTION 4.** The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached Indemnity and Trust Agreement signifying continued membership.

## **APPROVAL OF BILLS:**

Mayor Mironov specified the various bill lists and trust fund lists presented for payment.

Mayor Mironov asked that a bill at the top of page 3 on the Current 2016 bill list be held until a final decision has been made. Also, on pages 8 and 9 Mayor Mironov asked for some feedback on the auto parts bills and on page 10 questioned a bill for portable toilets.

It was MOVED by Shapiro, SECONDED by Zoller to approve the bill lists presented subject to clarification of questioned bills.

### **MATTERS BY COUNCIL:**

Mayor Mironov reported received: a memo from the Manager on bill list questions with respect to the November 22 meeting, a report dated December 9 from the Finance Director on the sale of bond anticipation notes, a report from the Tax Collector on the 2016 Tax Sale, a report from the Tax Collector for the period ending November 30, 2016, and two notices on partial roadway closure on Twin Rivers Drive for utility work.

Mayor Mironov stated that Public Works is working on the Senior Center tasks asked for, which were the wallpaper labor/work, the work plan for painting of rooms by Public Works, and the specification for the wallpaper to be purchased by the Township. In the meanwhile, Mayor Mironov had asked that Members weigh in on the wallpaper selections in Public Works. Mayor Mironov has gone through the paint available and suggests utilizing the paint colors currently there, with a few exceptions where similar colors should be used. Mayor Mironov showed suggested wallpaper samples to Council for their input. Council chose a wallpaper sample and two alternates. Mayor Mironov indicated that preparation of specifications can now move forward to have the work done in the spring with the exception of the work to be done by Public Works which will be done during the winter months.

Mayor Mironov stated that when the Police/Court building roof was discussed, there was a lack of clarity in the Public Works memo with respect to options 2 and 3 and as such Council considered going out to bid on both options. The Public Works Director feels that the options are very different and feels very strongly for one option. Mayor Mironov requested that the Public Works Director put together a memo to the Mayor and Council explaining in detail what each of the two options are and what the differences are and why he feels one is superior to the other.

Mayor Mironov noted that Deputy Mayor Yeager raised concerns as to Dutch Neck Road conditions and a memo from Public Works has been distributed in response.

Mayor Mironov stated that discussion was held at the last meeting with respect to the Phase 3 planting and the idea that the trees be planted on the Old York Road site instead of Etra Road. Mayor Mironov indicated that a new Resolution has been prepared and also a memo has been received from the contractor stating that he is willing to do so at the same cost.

**Resolution R2016-222** Action on Award of Contract for the Provision and Installation of 3000 Trees

## RESOLUTION R2016-222 EAST WINDSOR TOWNSHIP MERCER COUNTY

**WHEREAS**, the Township has been awarded from the New Jersey Department of Environmental Protection a No Net Loss Grant to fund a tree replacement program; and

**WHEREAS,** on March 7, 2016, East Windsor Township solicited bids for the Provision and Installation of 3,800 trees at various locations in the Township and on March 31, 2016, five (5) bids were received by the Municipal Clerk's Office; and

**WHEREAS,** on June 7, 2016, the Mayor and Township Council adopted Resolution R2016-073 awarding the contract to Downe's Tree Service, Inc. for the Provision and Installation of 800 trees at the Old York Road Open Space tract; and

**WHEREAS,** a separate component of the bid was to award the planting of 3000 trees at the Etra Road Open Space tract; and

**WHEREAS**, the lowest responsive bid for each of the locations was received from Downe's Tree Service, Inc.; and

**WHEREAS**, the Mayor and Township Council are desirous of planting the remaining 3000 trees also at the Old York Road Open Space Tract; and

WHEREAS, Downe's Tree Service, Inc. has agreed to the change of planting location; and

**WHEREAS**, the Mayor and Township Council have reviewed the recommendations made by the Public Works Director on the bids; and

**WHEREAS,** the Chief Financial Officer has determined that sufficient funds are available in the Account No. C-04-55-980-919-900 entitled Installation of Trees, in the amount of \$735,000.00, as evidenced by the Chief Financial Officer's Certification No. C2016-033.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, as follows:

- 1. The Contract for the Provision and Installation of 3000 trees at the Old York Road Open Space tract in East Windsor is hereby awarded to Downe's Tree Service, Inc., 65 Royal Avenue, Hawthorne, NJ 07506, on their bid of \$735,000.00 upon receipt of a fully executed contract and all other required documents.
- 2. The Mayor and Municipal Clerk are hereby authorized and directed to execute the contract for same.
