WHEREAS, among the terms of the Agreement, Rescue II shall execute and deliver to the Township a Deed for the property located at 73 Twin Rivers Drive, East Windsor Township, and designated on the East Windsor Township Tax Maps as Block 20, Lot 189.01; and

WHEREAS, on March 23, 2018, a Consent Order of Settlement was filed with the Superior Court of New Jersey, Chancery Division dismissing <u>East Windsor Township</u> Rescue Squad District II, Inc. v. PNC Bank, et als; and

WHEREAS, on March 27, 2018, a Consent Order of Settlement was filed with the Superior Court of New Jersey, Chancery Division dismissing The Township of East Windsor v. East Windsor Rescue Squad District II, Inc., Amanda Brooks, Jonathan Wassef, Brian Foley, Michael Foley, Matthew Potts, et. al; and

WHEREAS, The Township Council has determined that it is in the Townships best interest to accept the Deed in the attached form.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey as follows:

WHEREAS, in accordance with N.J.S.A. 40A:12-14(c), Rescue II is a nonprofit corporation and the provision emergency medical services within and on behalf of East Windsor Township is a public purpose; and

WHEREAS, the Township has determined that it is the best interest of East Windsor Township that the property located at 73 Twin Rivers Drive, in East Windsor Township, be leased to Rescue II under the terms of the attached Lease:

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer, and State of New Jersey, as follows:

Section 1. Authorization to Execute Lease. The Mayor and Municipal Clerk are hereby authorized and directed to execute the attached Lease between East Windsor Township and East Windsor Township Rescue Squad, District II, Inc. for the property located at 73 Twin Rivers Drive, in East Windsor Township (Block 20, Lot 189.01).

Resolution R2018-055 Adoption of the 2018 Municipal Budget

Mayor Mironov stated the Municipal Budget was introduced at the April 10 Council meeting and the Public Hearing was set for May 8. Mayor Mironov declared the Public Hearing open on the 2018 Municipal Budget Resolution R2018-055. With no comment from the public, Mayor Mironov declared the Public Hearing closed. Mayor Mironov indicated that Laurie Finger, the Chief Financial Officer for East Windsor Township and Francis Jones of Nisivoccia LLP, the municipal auditor, were present this evening. She asked them to indicate if the Division of Local Government Services had reviewed the budget document and had authorized them to adopt the budget tonight. Ms. Finger stated that they did give the Township permission to adopt the budget tonight.

Mayor Mironov stated the 2018 Municipal Budget, for the sixth consecutive year, has a no tax increase. She stated that the Township staff and Council members work very hard preparing the budget as well as throughout the year in monitoring revenue and expenditures in order to bring this positive result to the taxpayers. The municipal tax rate will remain at \$.43 per \$100 assessed valuation. Mayor Mironov continued, stating that in developing and adopting the budget, they remain sensitive to the taxpayers first and foremost, and if the Township were to utilize all of the tax levy cap available, they could raise the municipal tax rate by \$.07, but they are not doing that. She stated that this is the result of decisions they make because of their concern to provide high quality services while at the same time keeping the tax rate as low as possible and keeping expenditures as tight as possible to provide a budget that best serves the residents. Mayor Mironov stated that there were several reasons they had been so successful in creating the budget this year, including generating new revenue in a number of categories such as interest investments, the Municipal Court, and the Construction Department. There has also been a significant increase in the ratable base which has gone up \$54 million dollars over 2017 due to new businesses in the area and existing businesses expanding. They also look for other ways to economize, such as shared services with other municipalities like the dispatch shared services agreement with Hightstown Borough, and the recently installed solar panels at the Police/Court building, and the participation in several cooperative purchasing opportunities. The budget represents a great deal of work throughout the year and is a responsible, conservative budget that will serve taxpayers well.

Resolution R2018-088

Approval of East Windsor Township Anti-Idling Policy

RESOLUTION R2018-088 EAST WINDSOR TOWNSHIP MERCER COUNTY

WHEREAS, emissions from gasoline and diesel-powered vehicles contribute significantly to air pollution, including greenhouse gases, ozone formation, fine particulates; and

WHEREAS, numerous scientific studies have found links between exposure to fine particles and health effects including premature death, and increased incidents of asthma, allergies, and other breathing disorders; and

WHEREAS, the United States Environmental Protection Agency has classified diesel exhaust as likely to be carcinogenic to humans; and

WHEREAS, vehicle idling occurs in locations (e.g. school grounds, parking lots, distribution centers, strip malls, construction sites, business centers, etc.) where New Jerseyans can be exposed to concentrated sources of air pollutant emissions; and

- **WHEREAS**, asthma is a significant health concern in New Jersey, especially among children and the elderly; and
- WHEREAS, the reduction of fine-particle emissions from diesel engines could also prevent large numbers of new asthma cases annually and could save significant costs for health care and related expenditures in the State; and
- **WHEREAS**, for every gallon of gasoline used, the average car produces about 20 pounds of carbon dioxide (CO2), the largest contributor to greenhouse climate change, with one-third of greenhouse gas emissions coming from the transportation sector; and
- **WHEREAS,** petroleum-based gasoline and diesel fuel are nonrenewable fuels and should be used wisely and not wasted; and
- **WHEREAS,** idling is not generally beneficial to a vehicles engine because it wears engine parts; and
- **WHEREAS,** idling more than 10 seconds uses more fuel and emits more pollutants than turning an engine off and on again; and
- **WHEREAS**, current state law prohibits the idling of vehicles for more than three minutes and studies have shown that an anti-idling policy will save fuel, prolong engine life, and improve air quality.
- **NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of East Windsor, in the County of Mercer, State of New Jersey, supports the adoption of an effective anti-idling policy by government agencies, schools, businesses, and other organizations by:
 - 1. Enforcing violations and penalties under New Jersey's existing no-idling law pursuant to N.J.S.A. C. 39:3-70.2 and N.J.S.A. C. 26:2C-1;
 - 2. Encouraging any gasoline or diesel-powered motor vehicle to turn off their engines immediately at schools and off-site school related events to minimize exposure of children to vehicle emissions;
 - 3. Maintaining municipal vehicles to eliminate any visible exhaust and complying with the annual inspection requirement for those vehicles;
 - 4. Promoting the widespread use of emission controls in construction contracts (for example, see the "diesel Emission Controls in Construction

Projects; Model Contract Specification" developed by the Northeast Diesel Collaborative); and

5. Supporting broad education of the public about the health, environmental and economic impacts of idling and ways to reduce idling.
