ORDINANCE NO. 2015-08 TOWNSHIP OF EAST WINDSOR COUNTY OF MERCER

AN ORDINANCE AMENDING CHAPTER XX "ZONING" SECTION 20-18, "R-O RESEARCH OFFICE" OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EAST WINDSOR REGARDING REGULATIONS FOR HEIGHT, BUILDING COVERAGE, FLOOR AREA RATIO AND PROPORTION OF SPACE DEVOTED TO WAREHOUSE AND STORAGE IN BUILDINGS IN THE R-O RESEARCH OFFICE ZONE

BE IT ORDAINED by the Township Council of the Township of East Windsor, County of Mercer and State of New Jersey that Chapter XX, "Zoning," Section 20-18, "R-O Research Office," be amended as follows (new language is denoted by <u>underlining</u>, deleted language is denoted by <u>strike out</u>):

I

- 1. Section 20-18.1 "Principal Uses", subsection (c) is hereby amended as follows
 - c. The warehousing and storage of products within a completely enclosed building provided that no retail sales or motor freight facilities shall be permitted except as incidental and accessory to a permitted or conditional use. and further provided that the gross floor area devoted to warehousing or storage of products shall not be permitted to exceed 80 percent of the gross floor area of the building on the site.
- 2. The SCHEDULE OF DISTRICT REGULATIONS, for the R-O Research Office District, is amended as follows:
