## How To Use This Schedule?

1. Choose the direction you wish to travel and then locate the Weekday or Saturday schedule.
2. Numbered timepoints on the top of the schedule match the numbered timepoints on the map. Not all of the bus stops are timepoints. If your stop is between two timepoints, use the earlier timepoint as a guide to when the bus will arrive.
3. Read across the timetable to find the location where you want to get off the bus. Read down the schedule to find the time the bus will get there.
4. To find out what time you need to be at the bus stop to board, follow the time back across the schedule to where you are getting on. That is the time the bus is expected to be there.

### Where Does The Bus Go?

### What Will I Pay To Ride?

Bus service operates with the use of two vehicles and services the general public as well as WFNJ clients. The fare is one dollar each way, and exact change is required. WFNJ clients ride free by showing their county-issued welfare identification card.

### When Can I Ride The Bus?

Buses run from 5:30 a.m. to 8:12 p.m., Monday through Friday; and 7:00 a.m. to 3:56 p.m. on Saturday. The bus route offers easy access to transfers from select NJ Transit buses serving the City of Trenton. We provide service on most major holidays.

### Special Needs?

Customers with Mobility Impairments and passengers requiring the use of a lift-equipped bus must request a pick up by calling 609-989-6827 24 hours in advance.
